HAITI AND THE DOMINICAN REPUBLIC SHARE THE ISLAND OF HISPANIOLA AND ARE EXPOSED TO VERY SIMILAR, IF NOT THE SAME, HAZARDS. EARTHQUAKE FAULTS SPAN THE TWO COUNTRIES, TSUNAMIS GENERATED FROM OFFSHORE EARTHQUAKE FAULTS THREATEN COASTAL COMMUNITIES IN BOTH COUNTRIES, AND TROPICAL STORMS AND HURRICANES HITTING THE ISLAND AFFECT THE TWO COUNTRIES. THEY ALSO FACE SIMILAR CHALLENGES, BEING SMALL ISLAND NATIONS WITH LOW RESOURCES. OUR PROGRAM IN THE AREA FOCUSES ON EQUIPPING AT-RISK COMMUNITIES IN THESE COUNTRIES WITH ACTIONABLE INFORMATION ON REDUCING THEIR RISKS FROM DISASTERS. OUR ASIA PROGRAM PRIMARILY INCLUDES WORK IN BHUTAN, NEPAL, INDIA, AND THE PHILIPPINES. IN SOUTHERN INDIA AND THE PHILIPPINES, WE ARE FOCUSING ON REDUCING CLIMATE-RELATED RISKS, INCLUDING RAIN-INDUCED LANDSLIDES, AS WELL AS COASTAL HAZARDS. WE WORK CLOSELY WITH LOCAL LEADERS AND COMMUNITIES IN ALL OF OUR EFFORTS THROUGHOUT ASIA.

OUR GLOBAL PROGRAM INCLUDES AN ONGOING STUDY OF HOW EARTHQUAKE, LANDSLIDE, AND VOLCANO SCENARIOS HAVE BEEN USED AND HOW THEY CAN BE IMPROVED TO BETTER MOTIVATE DISASTER MITIGATION ACTION. THIS PROGRAM HAS INCLUDED GLOBAL LITERATURE REVIEW ON SCENARIOS, AS WELL AS MORE IN-DEPTH STUDIES OF SCENARIOS USED IN ECUADOR, NEW ZEALAND, NEPAL, AND THE UNITED STATES.
